

“SETTING THE RECORD STRAIGHT” – AN OPEN LETTER TO MEMBERS OF THE UNIFICATION MOVEMENT

June 17, 2025

Dear All,

An elder member and friend, P. A. Beltrami, wrote a letter dated May 20, 2025 on the occasion of Dr. Hyun Jin Preston Moon's (Dr. Moon) birthday, and enclosed it inside a book that he sent as a birthday gift. The birthday present book had a simple birthday card attached to the exterior, but inside the present was hidden the 5-page letter directed to Dr. Moon, that was obviously the real reason for the send. This covert way of sending his real letter was surprising and was a reminder that some members unacceptably see themselves as being on an equal footing with the members of the True Family and can relate to them in any fashion they like. This is not Heavenly tradition or even common courtesy.

As a member of a committee that regularly reviews such incoming letters, it came to my attention. After reading it, I realized that even after 17 years of Schism and mountains of evidence, there is sadly still a great need for “setting the record straight” for many Unification Movement members. In this case, P. A and his HDH group included. This “open letter” to P. A. and to all of you is my attempt to do just that – for the benefit of all.

P. A., the gist of your letter appears to me to be a request for the three sons of Rev. Moon, ie Dr. Hyun Jin Preston Moon, Hyung Jin Sean Moon (Sean) and Kook Jin Justin Moon (Justin) to “lay down their differences” and just unite, with the implication that Dr. Moon should be the first to do so. You also imply that if he did so, he would become a true “Biblical figure” or champion. Further, the court cases that have wasted extreme amounts of providential funds could come to an end. Basically, you are saying that we should just forget the past. “Can't we all just get along?” is a phrase that comes to mind. This is an inappropriate, even insulting, viewpoint and request to be given directly to Dr. Moon at this time. The reasons for this are both numerous and important to understand. It is certainly NOT because Dr. Moon has given up on his family; far from it. But to understand clearly, one must know the bigger picture because we are talking about God's Providence, which He is leading through Principles that are unchanging. In essence, as we know, the Providence is an overall battle between God and Satan – thus between Good and Evil - therefore much more than familial relationships are involved. Dr. Moon, after all, is the son who has taken responsibility for the Providence ever since 1998. There are serious consequences for going against God's Providence.

We all need to know how disunity was fomented within the True Family, which resulted in the Movement-wide schism. So, I will start from there.

JUDGEMENT FROM REV. MOON'S WORDS

Many of those who have seriously investigated the origins of the Unification Schism have found a direct correlation between the onset of attacks directed at Dr. Hyun Jin Preston Moon (Dr. Moon) and the subsequent unprincipled “Reversal of Dominion” fomented by Mrs. Hak Ja Han (Mrs. Han) against both her husband, Reverend Sun Myung Moon (Rev. Moon) and his appointed heir, Dr. Moon. The “Only Begotten Daughter” (OBD) theology espoused by Mrs. Han has proven to be the antithesis of the “*Divine Principle*” taught by Rev. Moon and upheld by his son, Dr. Moon. Rev. Moon, in his last known video-taped morning service, denounced those leaders who helped in dividing the True Family, attacking his heir and creating the Schism, as “worse than Lucifer”! Such strong words of condemnation by the Founder of the Unification Movement simply cannot be ignored, especially by members who still hold love and respect for him. As you see in the video, Rev. Moon explained that these leaders, like Lucifer in Eden, had disrupted Heaven’s plan for the True Family and for humankind; therefore, he condemned them in the strongest way. Rev. Moon had learned just before this video-taped morning service that this “cabal” or “Luciferian Group” had lied to him for years as they had character assassinated his son, Dr. Moon. Therefore, he strongly wanted to “set the record straight” himself – and he did so, holding nothing back. To be judged as “worse than Lucifer”, the Luciferian Group had to commit great evil. How evil was it that they took advantage of the person they themselves saw as the Messiah in his old age by continually lying to him and destroying his legacy plan by attacking the son he had designated as his successor? Sadly, until now, many members of FFWPU and Sanctuary have never even seen this all-important video or found out the truth of how they created the Schism.

The underlying reason the Unification Schism could happen is because most members had the wrong theological understanding of the *Divine Principle*. They failed to recognize that the *Divine Principle* black book was really an effort to deconstruct the Christian creed framework, which establishes that Jesus is fully divine, shares in God's essence, and emphasizes the Trinity. Rev. Moon came to make clear the mission that Jesus had to embark upon as God's son and also to dispel the notion of his divinity. The

Divine Principle makes it clear that the Messiah is a man, not a deity. He is an *Adamic Figure*.

Even though the thesis of the first half of the *Divine Principle* is a deconstruction of the traditional Christian view, UC members now have adopted that very framework! Instead of enlightening the larger Christian community as to the new insight of the truth revealed through the *Principle*, UC members adopted it and went into the same ignorant box by replacing the “divine” Jesus Christ with the “divine” True Parents.

This false deification is significant because it set the framework for the schism- the Luciferian Group adopting the false concept of the divinity of the True Parents, while Dr. Moon stayed true to the original teaching that made clear the messianic mission and identity.

The UC leaders' adoption of the divinity framework goes completely against the *Divine Principle*, because it tries to divinize **both** True Parents. The UC then used the false base of divinity to advance the notion of *coequal status* of the True Parents, as a way to elevate Mrs. Han's standing to that of an equal to Rev. Moon. Mrs. Han then had outsized power to apply in her struggle to eliminate Dr. Moon. Having artificially elevated Mrs. Han's stature to rival that of Rev. Moon, the Luciferian church leaders took evil advantage of Rev. Moon during the last years of his life, when his capacities were naturally limited. They adopted the agenda of elevating Mrs. Han in order to communicate to members that various instructions came "from the True Parents," but there were many instructions that actually came from Mrs. Han, without Rev. Moon's involvement or knowledge. That is the unprincipled foundation used by Mrs. Han to elevate Sean and Justin to higher and higher positions.

Also, having a proper grasp of the original teaching of “reversal of dominion” as taught by Rev. Moon in the *Divine Principle* black book is central to understanding the crimes committed by the OBD regime - because those crimes mirror the original sin committed by Eve in the Garden of Eden - an act that led to the fall of Adam and ultimately to the killing of Abel by Cain.

Mrs. Han reproduced Eve's mistake by elevating the younger sons, Sean and Justin, to oppose and attempt to destroy their elder brother, Dr. Hyun Jin Moon, who stands as the anointed Adamic figure and is central to the messianic mission. While Eve's sin resulted in Satan claiming Cain and leading to the murder of Abel, Mrs. Han's actions are even more grievous, as they took place within the True Family, which is under God's direct dominion. In this context, Mrs. Han reversed the natural order of love, aiding the

younger sons in usurping the position and birthright of the elder son, who was already properly claimed by God by virtue of Rev. Moon having established the True Family.

Satan had dominion over Adam's family because of the fall where Adam and Eve created the 4 Position Foundation (4PF) centering on Satan. Therefore, Satan was able to claim eldersonship; thus, God had to work through Abel to restore the eldersonship. Do not mistake this with True Family where Father Moon established the 4PF centering on God and claimed the eldersonship through the recognition of Dr. Moon as the fourth Adam. With this Father-Son cooperation as the foundation he could claim the 3 Kingdoms and the recognition of God's Sovereignty and the kingdom of Chun Il Guk.

Sean's use of the Cain and Abel framework to prop himself up as the "Abel" figure because he is the younger brother is misinformed, disingenuous, and opportunistic. The restorational Cain and Abel framework does not, and should not apply in the True Family, which is within God's direct dominion. To talk about himself as Abel and the older brother, Dr. Moon, as Cain, not only shows a complete lack of understanding of the *Divine Principle* but also undermines Rev. Moon's messianic mission and the status of the True Family.

This spiritual crime reached its climax when, just weeks before his passing, Rev. Moon denounced the corrupt church leaders in the last video-taped morning service that you have just seen. The video that is linked here that shows Rev. Moon condemning church leaders as "worse than Lucifer" took place right after an WFWP event in 2012, where in front of ten thousand participants, Rev. Moon said he has no wife, and that Mrs. Moon betrayed and abandoned her providential role and responsibility by not uniting with him. [\(link\)](#)

LUCIFERIAN GROUP LEADERS AND THEIR TACTICS

Who are the core members of this Luciferian group? Central agents for leading the attacks against Dr. Moon, thus creating the Schism, and going against Rev. Moon's directions, were the two younger brothers, Sean and Justin Moon, their mother Mrs. Hak Ja Han, and a number of unscrupulous church leaders. An unprincipled *quid pro quo* arrangement was carried out between Mrs. Han and the two younger brothers in their campaign to hijack the leadership role from Dr. Moon. Mrs. Han would unjustifiably elevate Sean and Justin to higher and higher positions of leadership within the movement while Sean and Justin would lead the way in promoting the unprincipled

deification of Mrs. Han - leading to her later title and false position of “Only Begotten Daughter of God”.

All three of them also collaborated to go against Rev. Moon’s edict of “End of the Church Era” by continuing promotion of the institutionalized Unification Church (UC) instead of supporting the Unification Movement as a providential vehicle that went beyond religion or denomination as Rev. Moon had demanded. This continued focus on UC was pleasing to the corrupt church leaders of the Luciferian Group, who benefited personally and selfishly by being able to retain their favored positions within the church structure. It did not matter to them that the Providence called for a dramatic change after Rev. Moon’s 40 – years Wilderness course had ended successfully. That change – as evidenced by Rev. Moon’s creation of numerous “peace” organizations beginning in the 1990s – meant that finally, after the Wilderness Course was forced upon him by the failure of key Christian “John the Baptists”, Rev. Moon could begin his original mission; which was the salvific work of building God’s substantial Kingdom of peace on earth through the universalized Blessing movement. Taking advantage of Rev. Moon’s elderly age, directives in the form of UC public memos were being issued by Sean with Mrs. Han’s approval; alarmingly, these were often issued without the knowledge or consent of Rev. Moon. Yet, the memos issued to the membership and public gave the false appearance that Rev. Moon had somehow endorsed those public memos. The truth was that UC leaders used Mrs. Han’s approval to claim “True Parents” had given their approval or blessing. According to Mrs. Han’s 2018 deposition testimony, after Sean gained control of Family Federation for World Peace and Unification (FFWPU) he even had the official name changed to “Unification Church” without Rev. Moon’s knowledge! This caused great confusion for the entire Movement and was a strong move away from God’s Providential direction.

Dr. Moon, who was always united with Rev. Moon and championed God’s providential goals, drove the rapid development of FFWPU and peace organizations, including Universal Peace Federation, across the globe. In 2008 alone, he held huge Global Peace Festivals and conferences in 24 nations, reaching millions with the message of “One Family Under God”. It is no wonder then that the Luciferian Group saw him as the main threat to their determination to put all focus on the Unification Church. Sean and Justin specifically ridiculed the cause of Peace in public speeches - expressing that the only thing that really mattered was the institutional church.

Sean was also promoted by Mrs. Han as the “true heir” to Rev. Moon and ultimately, was given the role (usurped from Dr. Moon) of international leader of FFWPU and World CARP (the main youth organization that Dr. Moon had built up). Later Sean even took

over Universal Peace Federation (UPF). HOWEVER, once Dr. Moon was stripped of all leadership roles and Rev. Moon had passed away, Mrs. Han not only rescinded the leadership roles she had given to the two younger sons, but also unceremoniously booted them out of FFWPU altogether! She then testified under oath ([link](#)) that Sean “had never been the heir”because he “had the understanding of a middle schooler when it came to the *Divine Principle*”. The mother that Sean and Justin had done their best to deify they now publicly called “the Whore of Babylon”! Although Sean and Justin were happy to work with corrupt church leaders **as long as they were attacking their elder brother**, once they were expelled themselves, they regaled the same leaders and Mrs. Han with unending accusations of deception, evil intent, etc. The FACT is that all the things they accused Mrs. Han and corrupt leaders of, were things that they themselves were guilty of as well. Their hypocrisy knows no bounds.

Further, Sean and Justin have done tremendous damage to the Providence. Not only did they lead the attacks on their elder brother and Fourth Adam, but their actions are also directly tied to Rev. Moon’s early passing before accomplishing the important providential goal of Foundation Day (Jan 13, 2013). That significant providential goal which remains unfulfilled will be accomplished by the Fourth Adam. Members need to realize that Sean and Justin were the ones who first promoted the Only Begotten Daughter “theology” that allowed the reversal of dominion to occur within the True Family and the Movement, further enabling the Schism to happen. Sean’s ridiculous claim to be second king of CIG is preposterous, given the fact that Foundation Day never happened, there never was any *first* king of CIG, and given that he is completely unqualified. Yet Sean fostered the notion that he was the supposed heir while coming to confirm all of the negative cliché-ridden criticisms of our Movement’s detractors. Today Sean is the poster child of every negative caricature of our Movement. Their false claims to “Kingship”, near “worship” of the AR-15 automatic rifle with its inclusion as a central part of their Blessing ceremony, “Crown of Bullets”, etc. have done great damage to Rev. Moon’s and his Movement’s image. Detractors of the Movement love now to show photos of the gold AR-15 in the Blessing ceremony and Sean with large groups of Sanctuary members brandishing their weapons, to illustrate how radical the Moon “Group” is! However, nothing was nearly as egregious and damaging to image as their “re-Blessing” of Rev. Moon to the ancient Mrs. Kang and their designation of her as the new “True Mother”. They outrageously made Rev. Moon’s image into a laughingstock! For all of these evil actions, and more, they must repent before they can hope to see Dr. Moon. (P.A., don’t you agree that it is way past time to end all support for these unprincipled and false leaders?)

P.A., you mentioned about “Biblical figures” and Dr. Moon possibly becoming one IF he is the first to unite with his brothers. Think how insulting your words would be to the person who has never laid down full responsibility for the Providence ever since he accepted the position of Fourth Adam - now nearly 27 years ago, and despite being under all-out attack for the last 17 years!

The New Testament tells the story of Jesus Christ, which is very pertinent to the situation that unfolded in the Movement. This is Jesus' response when his own mother and siblings tried to seek him out:

While He was still talking to the multitudes, behold, His mother and brothers stood outside, seeking to speak with Him. Then one said to Him, “Look, Your mother and Your brothers are standing outside, seeking to speak with You.” But He answered and said to the one who told Him, “Who is My mother and who are My brothers?” And He stretched out His hand toward His disciples and said, “Here are My mother and My brothers! For whoever does the will of My Father in heaven is My brother and sister and mother.” (Matthew 12:46-50)

Jesus tells the multitude that those who walk with him centered upon his mission to Heavenly Father are the ones that are his mother and brothers and sisters. Dr. Moon is the Fourth Adam and is in absolute alignment with Rev. Moon, the Third Adam. It is upon that foundation of unity that the Three Kingdoms are founded. When members centered on the cabal of Mrs. Han, Sean, Justin, and UC leaders, they abandoned God, Rev. Moon, and Dr. Moon. Only those who stayed true to God and His providence are Dr. Moon's real parents, brothers, and sisters.

In the Old Testament there are also stories of providential figures with parallels to Dr. Moon's course. One such central figure is **Joseph**. Those who are up to date with the situation in the UC will know of the steep decline it is experiencing worldwide: the Unification Church of Japan is facing dissolution at the hands of the Japanese government - a measure that the vast majority of the public of Japan favor. Meanwhile in Korea a major corruption scandal for the bribery of the former president of Korea has put Mrs. Han and the Unification Church in the crosshairs of an investigation by public prosecutors. That investigation may soon unearth even further wrongdoing that could lead to Mrs. Han being incarcerated. This is divine judgment that is falling upon the UC and continues to fall on those who perpetuated this crime, similar to what happened in the life of the biblical Joseph. Joseph's siblings were jealous of his relationship with his father and wanted to get rid of him. Fueled with resentment, the siblings plotted to kill

Joseph but ended up selling him into slavery behind their father's back. They then lied to the father about Joseph, saying he was killed by an animal, to cover their tracks. But rather than succumb and become subdued, Joseph as God's champion rose to prominence in Egypt with Heaven's protection and blessing. However, the brothers suffered greatly because God sent famine to Canaan, forcing them to have to go to Egypt and face Joseph, who was in charge of grain supplies. Joseph had to test his brothers' character through a series of trials before forgiving them.

This is what is happening in the UC now. Tremendous heavenly judgment is coming to those who attempted to get rid of Dr. Moon behind Rev. Moon's back by sending him into the wilderness, causing the schism. Today Dr. Hyun Jin Preston Moon has risen to national prominence in Korea by leading the largest grassroots movement for unification in the history of South Korea. This coalition is galvanizing the disparate divided factions within Korean society, as well as Korean politics, based on the unifying vision that is rooted in Korea's historic providential destiny that Dr. Moon outlines in his acclaimed book *"Korean Dream."* Internationally, through the Global Peace Foundation (GPF), Dr. Moon is recognized as a leading advocate for peace, particularly in areas plagued by deep-rooted conflict and division. Under his vision and leadership, GPF has pioneered a values-based approach to peacebuilding that emphasizes universal principles, shared identity, and moral leadership. Dr. Moon's strategic emphasis on national transformation has guided GPF's work in divided societies such as the Korean peninsula, Kenya, Nigeria, Paraguay, Philippines and many others, fostering grassroots movements that transcend political, religious, and ethnic divides. Through various initiatives and interfaith leadership platforms, GPF has built broad coalitions among civil society, government, and faith leaders to address root causes of conflict and promote sustainable development. As a result, Dr. Moon has established a growing global network of partners committed to the vision of "One Family under God," amplifying peace efforts across Asia, Africa, and the Americas.

So, P.A., can I assume that Dr. Moon's success is why you are now stepping forward to propose reconciliation on behalf of the two brothers – after all they have done to Dr. Moon? If they truly seek reconciliation, they must first take personal responsibility for their actions and sincerely repent. Dr. Moon is not just an individual or just one of Rev. Moon's sons. He stands in the position of an Adamic figure, representing Heavenly Father's authority. What they violated was not just a humanistic brotherly relationship, but they have wronged Heavenly Father and His providence.

The contradictory actions and statements by both Mrs. Han and the younger brothers toward each other prove that their campaign to mutually elevate each other to the

detriment of God's Providence, to the **detriment** of both the Third and Fourth Adams, and to the **detriment** of all UM members, was a huge sham in totality – a sham that continues to be perpetrated on most members of the Movement even today. The members continue to be mistreated in this way, **simply because they allow it to continue!**

Sean and Justin's actions demonstrate profound derangement, lack of common sense and decency, and not an iota of responsibility for what they have done. As members of the True Family, their roles were instrumental in destroying Rev. Moon's work in his generation. The damage done by this cabal is far greater than the mere reputational harm they caused to the Movement—they betrayed and damaged God's providence. Now Dr. Moon must carry the mantle of properly settling the True Family ideal to bring fruition to God's will. As far as I know, Dr. Moon unequivocally disavows any association with them and will not recognize them as members of the True Family – until they own up to what they have done and repent.

False "Three Sons" Leadership Concept

Another important part of the campaign to attack Dr. Moon was to lessen his authority by promoting an unprincipled "Three Sons" concept of leadership. This completely bogus scheme posited that the movement's leadership should be divided into three parts, each part led by a different brother. By ignoring the central Adamic role, this false concept made it appear as if the three brothers were essentially equals in the Providence. This would be comparable to Jesus' brothers or Rev. Moon's brothers claiming to have equal authority with their sibling. The entire concept was "cooked up" by Mrs. Han and the two younger brothers and promoted by corrupt church leaders. The undeniable truth is that God works through a central point; thus, the Providence and the genuine Unification Movement have always been led by a charismatic Adamic figure.

Rev. Moon recognized only four Adamic figures in his lifetime - 1. The original Adam, 2. Jesus Christ, 3. Rev. Moon himself, 4. Dr. Hyun Jin Preston Moon. Dr. Moon was appointed by Heaven to be the Fourth Adam and recognized as such by Rev. Moon in July 1998. He then successfully co-led the entire Unification Movement with Father Moon for over 10 years - until the Luciferian Group's Satanic attacks on his character and positions destroyed the unity within the True Family and the Movement. There was NEVER a "Three Sons" approach to overall leadership of the Providence and there never will be – just as there is no legitimate justification for a position called "Only Begotten Daughter". That is - no justification whatsoever - **theologically, scripturally or historically!**

Detractors of the Unification Movement often exploit the extreme and troubling images of the Sanctuary Church to disparage the entire Movement. It is essential to clarify: the concept of 'three sons' as joint successors is wholly unfounded. Providentially, the younger sons were never relevant in comparison with their elder brother. There has only ever been one legitimate successor to Rev. Moon – Dr. Hyun Jin Preston Moon.

The Parallel Courses of the Four Adamic Figures

ALL of the Adamic figures have been the target of Satanic attack, simply because they represent God's side and will not bow to any pressure(s) to abandon their mission. This has produced parallels common to the courses of all of the Four Adams.

Satan's attack on the first Adam led to his family and lineage coming under Satanic dominion, necessitating the Providence of Restoration to begin from God's side. According to the *Divine Principle*, when Jesus could finally come, Satan invaded John the Baptist and the religious leaders of the time and they viciously attacked Jesus - presenting outrageous lies to both their rulers and to the people in general. Because of the failure of John the Baptist, Jesus had to go the way of the cross, opening the door for the spiritual salvation yet making it clear he would have to eventually come again to fulfill his original mission.

When Rev. Moon came as the Third Adam, certain Christian leaders were prepared as his "John the Baptists". They also fell under the sway of Satanic forces and came to lead the attacks on Rev. Moon with many false accusations. The lies were spread by the media to the leadership and the common Korean people. **Rev. Moon's mission was delayed** as he had to build his own worldwide foundation through the 40-years Wilderness Course before he could begin his original mission of bringing peace to the world.

This same pattern has repeated in the course of the Fourth Adam, Dr. Moon. Rev. Moon suddenly appointed certain younger leaders to the highest positions of leadership - in some cases, even over 36 couples! Rev. Moon instructed them that they were given such high position simply because they were closer in age to Dr. Moon and could therefore be better supporters and "John the Baptists" to him. The people that Rev. Moon appointed were mostly from the 6,000 couples blessing, referred to as the "1.5 generation". He expected that leaders of the 6,000 couples would support his son and heir, Dr. Moon, in the critical moment of transition. It is this very group of people that Rev. Moon chastised and cursed as being "worse than Lucifer" because they betrayed Rev. Moon and his trust in them.

Instead, as these leaders also got invaded, they became members of the Luciferian Group and turned against Dr. Moon, engineering all manner of false accusations against him – reporting these lies both to Rev. Moon AND to the general membership. As described below, 30 court cases were unjustifiably brought against Dr. Moon. Sadly, these evil actions against him were led by his own mother and siblings. As with his father, Dr. Moon was forced to overcome a delay in the Providence.... building his own worldwide foundation through a 21- year course of restoration, which he has done with amazing success!

BOGUS COURT CASES

In the Unification Movement's entire history, using any court system to decide important issues regarding the Providence, **never happened**. No one was ever brought to court by the UC, much less a member of the True Family! This was true UNTIL the Luciferian Group decided to use bogus court cases in a futile attempt to force Dr. Moon into submission. **The cabal initiated some 30 court cases on three continents against Dr. Moon and/or his associates. Again, in our Movement, legal action was never the means to resolve matters – not even against those who deserved it. This is because our Movement was meant to be a salvific movement for the restoration of humanity, elevating it from its fallen state. Coveting power, position, and control over assets, the unqualified cabal, including the two younger brothers, started filing lawsuits as a means to take legal control of the Movement's entities, regardless of the tremendous damage the lawsuits would cause.**

P. A., as you point out, exorbitant amounts of Heaven's blood money (many millions of \$) were wasted on these Satanic legal attacks. Sean, Justin and Mrs. Han initiated and continuously supported all these cases, not caring about their costs in either finances or negative public image for the Movement. HOWEVER, P. A. you do not acknowledge that Dr. Moon was the target and victim of **all** of these sham court cases. He did not initiate **any** of them. He was forced to defend himself again and again. Although the FFWPU side would be losing a given case, their modus operandi was to endlessly enter appeal after appeal, greatly driving the costs up in both time and \$.

TIMELY AND TELLING COMPARISONS

Now, in the third 7-years of Dr. Moon's 21-year course since being betrayed by his "John the Baptists" and his own family in 2008, the tide has clearly changed. It is becoming clear to those "who have eyes to see" that Heaven's favor is with Dr. Moon and clearly NOT with Mrs. Han OR Sean and Justin. Even a cursory comparison of a few key areas reveals this to be the case for every member to know. Please consider:

Under "Only Begotten Daughter":

COMPLETE LOSS OF FINANCIAL CENTER AND STABILITY

The root cause of the current crisis facing FFWPU is not just misfortune or external pressure; it is corruption and gross incompetence at the highest levels. Since the 1970s, Japan had been the financial engine of the UC and FFWPU. But now, FFWPU Japan faces official dissolution by the Japanese government, a stunning fall from its once-pivotal role. Globally, FFWPU is teetering on the edge of bankruptcy, having spent the last few years frantically selling off properties across multiple continents.

One of the most striking recent losses is 4 West 43rd Street, a flagship property for the American movement for over 50 years—now gone. It joins a long list of U.S. properties purchased by Rev. Moon that have been squandered under Mrs. Han's leadership. Demian Dunkley has even warned that the iconic New Yorker Hotel is on the verge of being lost.

At the heart of this financial collapse lies a pattern of reckless mismanagement and self-serving decisions. Chief among them is Mrs. Han's obsession with constructing a massive "mega palace" at Cheong Pyeong—a monument to vanity that has drained astronomical amounts of public funds. Yet this project is merely one symptom of a much deeper rot. Tens of millions have also been wasted in the 30 frivolous lawsuits against Dr. Moon, driven by pettiness rather than principle.

This is what happens when an unqualified and corrupt leadership clings to power. Everything the so-called "Luciferian Group" touches deteriorates, not by accident, but because of a toxic mix of arrogance, incompetence, and betrayal of the Providence. By contrast, only Dr. Hyun Jin Moon has consistently demonstrated the capacity, integrity, and vision necessary to lead the movement into the future.

COMPLETE EMBROILMENT IN BRIBERY SCANDAL AND TOTALLY NEGATIVE MEDIA IMAGE IN KOREA

In April, FFWPU was riding high with the Grand Opening of Mrs. Han's Second Palace. Then, in less than a week, Mrs. Han herself and FFWPU as a whole, found itself in a devastating legal and media firestorm over a Korean government bribery scandal involving the former President and his wife being bribed by FFWPU officials. This latest imbroglio under Mrs. Han is even more pervasive and damaging than the one in Japan that is officially bringing down FFWPU there. Daily reports in all forms of Korean media reveal the sordid facts of "Quid pro Quo" bribes in the forms of expensive Chanel bags (of roughly \$10,000 each) and a now famous expensive (\$60,000) necklace going to President Yoon's wife in exchange for several favors, including governmental support for a Cambodian development project favored by FFWPU, etc. To date, the government has raided the office of Youngho Yoon (who until recently was the #2 FFWPU official under Mrs. Han), his home, the main company offices of Chanel, and the shop of Mrs. Han's personal jeweler. Greatly adding fuel to the fire, Youngho Yoon reported to investigators that all directions for the bribery activity **came from Mrs. Han herself**, effectively "throwing her under the bus". Subsequently, Mrs. Han and her closest associates have been put under an official travel ban by the government. She tried to secretly escape the fire storm by leaving Korea on a private jet from Kimpo Airport but was turned back because a travel ban was issued against her since she was declared to be a person of interest in this bribery scandal. It is clear that eventually the prosecution's focus will turn to Cheong Pyeong and the role of Mrs. Han and her key associate, Mrs. Wonju McDevitt.

FFWPU leadership is so fearful that word of this scandal will spread to other nations that they issued a public memo on May 24, 2025, blaming the entire corruption scandal on one person: Youngho Yoon. The Family Federation leadership took zero responsibility for these acts. North America Regional Chairman, Demian Dunkley issued a most ludicrous official letter to all members. He stated that there is nothing to this scandal.....and yet, members should not even discuss it among themselves! Such childishness and incompetence is indicative of the unqualified, inept, ineffective, clueless and honestly hopeless leadership of FFWPU that is leading to its continual demise.! What Dunkley doesn't acknowledge is that there would be a lot more evidence exposed to the public constantly via the prosecutor's office and the Korean media. The most damaging by far are over 5,000 pages of documents from Young Ho Yoon's computer along with recorded audio conversations that directly implicate Mrs. Han and her top associates. All of this is in the prosecutors' hands. It is beyond irresponsible to tell members that they have nothing to worry about. Korean prosecutors have far more investigative legal power than their counterparts in other countries. The fact that the newly elected President and the National Congress of Korea passed a law to activate a special prosecutorial body that has powers beyond the regular Korean Prosecutor to

investigate this case shows just how tenuous and dangerous this current situation is for Mrs. Han. Clearly, Dunkley is totally irresponsible in his public letter to the unknowing members.

FFWPU will undoubtedly claim that Mrs. Han's situation is similar to the persecution that Father Moon received in the Danbury Case. They will try to draw parallels. But nothing could be further from the truth. The difference is that Father Moon did nothing wrong. He was unjustly persecuted and prosecuted based on an accounting error. Because of his innocence, thousands of ministers came to his defense, lifting him up. Many others also faced similar accusations of tax evasion but were let off, simply paying fines. He did not purposefully try to engage in illegal activities. But, in Mrs. Han's case, it is hard to say that she is not guilty considering: The prosecution has Yoon's words that Mrs. Han ordered him to perform his corrupt actions; there is substantial evidence of the quid-pro-quo transaction, as well as the 5,000 pages of documentary evidence uncovered by the prosecution's investigation. This evidence includes Mrs. Han admitting that she controls the FFWPU. Yoon is telling the prosecution that Mrs. Han was informed and that she gave the orders. There is no comparison between Father's Danbury situation and Mrs. Han's likely prosecution.

The media image of FFWPU and Mrs. Han herself could not be worse. Already damaged by the constant negative media from Japan which reported ad nauseum about how one Korean woman (Mrs. Han) was pressing stressed Japanese families for more and more donations for her palace, she is now seen as one who actually enabled the bribing of a sitting Korean president and his wife! Whereas Japan, now lost, had been the *financial center and base* for the Movement, Korea has always been seen as the *spiritual center and base*. In a short time, under Mrs. Han, there is the real possibility of both essential bases being lost to FFWPU!

By accomplishing what most elder members of the Movement would think impossible, Dr. Moon has generated a totally positive image within the public and especially in the Korean media. Major news outlets at their requests, including *The Korea Times*, have published regular columns from him ([link](#)). All forms of media are constantly requesting personal interviews with him. There even was a full-length documentary about his peace and reunification work internationally that has been shown a number of times throughout Korea and in neighboring nations. Korean mainstream media has covered Dr. Moon's work thoroughly, especially his work for Korean reunification. Korea has 2 major cable news channels, of which Yonhap is one (you can think of it like the CNN or Fox News of Korea). Such a major media entity would never have done a lengthy piece on the positive work of our Movement before. Dr. Moon's conferences and large rallies are always positively and widely covered in print and electronic media. Especially popular was the large rally last year held at the 38th Parallel in the DMZ. ([link](#)) **On top of that the platform for unification that Dr. Moon outlines in the Korean Dream has been adopted by the Korean Government as the stated policy for unification of the Koreas. Also, the international framework to support the Korean Dream's approach to unification has been adopted by the USA, Japan, and Korea through a tripartite alliance, adopted at Camp David.**

Perhaps ironically...or is it "good Karma"?...the onslaught of negative media coverage now inundating Mrs. Han and FFWPU is not affecting Dr. Moon's image or work at all. This is because all of the media (and public) are well aware of how the FFWPU and UC attacked Dr. Moon and his family so viciously for the last 17 years. Korean people paid special attention when Dr. Moon and his family were left off the official family list of the bereaved family members that was given to the press by FFWPU - as well as his family having been physically blocked by UC members from even attending his father's funeral! The accumulative effect was the widespread education to everyone that Dr. Moon has nothing to do with the UC, FFWPU or any of their criminal enterprises.

Sanctuary Church members must recognize the arrogance inherent in their assumptions, as well as in the expectations they have towards Dr. Moon.
